

**Town of Casco** Selectboard Minutes

February 1, 2022

Selectboard Chair Mary Fernandes opened the meeting at 6:00pm.

Chair Fernandes asked for motion to approve the agenda.

- 6. Managers' Report
- Manager sought seeking guidance on the Budget meetings schedule. Last year you meet every Thursday to discuss certain budget lines. Would the board prefer to maintain this type of schedule? Would you like a budget committee to be convened for this budget process?
- The Town's assessor recently completed the Town's 2022 Preliminary report for tax rate calculation and advised that our ratio is currently at 78%. This drop in our ratio is due to changes in state law that recently took effect and the booming housing market. While the assessor originally anticipated a 2025 reevaluation, he is recommending the process begin during the FY23 and FY24. He recommends a complete reevaluation and not a market analysis because of the complex and everchanging market. Reviewing of previous budgets reveal no funds have been placed into a general fund for this service. The anticipated cost for a complete reevaluation should be in the area between \$257, 460 and \$275, 850 (\$70-\$75 per parcel). This change in ratio proportionally changes the amount of homestead received by our residents. Instead of a \$25,000 Homestead exemption, our residents will receive \$19,500. The Town will receive reimbursement of 73% on all the Homestead Exemptions.
- The Ad Hoc Committee on Short Term Rentals will reconvene next week. I anticipate a draft shortterm rental and noise ordinances being available in the near future for Selectboard review and being prepared for June Town Meeting.
- An internal survey of employees related their benefits is being conducted. Employees have until end of day today for completion of the survey. Included in your packet is a copy of the survey.
- A new sign was installed on Friday morning and is in full operation. The signs capabilities greatly improve our communication abilities.
- Two icing problem continue on Town roads even with Mike Genest working on these areas daily. The areas are Heath Road and Quaker Ridge Road at the power lines. Both of these icing problems are designed related and Quaker Ridge Road problem is compounded by the snow mobile trail. Future ditching and culvert work should resolve the repeated icing difficulties.
